Directions under Section 35A of the Banking Regulation Act, 1949 (AACS) - read with Section 56 of the Banking Regulation Act, 1949 - Withdrawal of deposits in excess of stipulated amount — The Mapusa Urban Co-operative Bank of Goa Ltd., Goa

Please refer to order DCBS.CO.BSD-1 No. D-6/12.22.156/2015-16 dated July 24, 2015 imposing directions on your bank.

- 2. In this connection, we advise that for considering requests for withdrawal of deposits in excess of the amount stipulated in the directions on grounds of hardship you may constitute a "Screening Committee" comprising of the CEO/GM, one or two officers of the bank and a representative from the staff union / depositors' forum as members.
- 3. Depositors approaching the bank to withdraw deposits above the prescribed ceiling amount on medical, marriage, livelihood, education etc. grounds would apply in prescribed format. This committee would examine applications / requests on the basis of supporting documents submitted by the depositors. The committee should then recommend the only deserving cases to RBI in prescribed format for its consideration together with supporting documentary evidence, extract of Committee resolution, etc.
- 4. You are advised to obtain the applications from the depositors for withdrawal on hardship ground as per the enclosed format No. I. On receipt of the application the
